| 2018 EVENT SAFETY RULES |

Pony Party Bus Event Safety Rules & Regulations:

- **Closed Toe Shoes must be worn while riding in the cart and when standing near, or by the pony and cart. No “open toe” shoes/sandals/flip flops allowed near the pony cart or pony at ANYTIME.**
- **Parents & Children** must stand in line and wait for their turn!
- Children are not allowed to ride in the cart in wet bathing suits or wet clothes.
- Dogs are **NOT** allowed around the pony. ***Dogs must be inside the house and/or on a leash for the duration of the event.***
- Parents/Teachers/Caretakers are responsible for watching their children at all times.
- Day Care centers must assign an event designated teacher to direct their students to each pony station
- ****Applicable For: Pony Parties with guests under the age of (2): *Children that are too young and too small to hold on by themselves must be accompanied by an adult while they ride in the cart for a photo only! No child under the age of two is allowed to ride in the pony cart alone.***
- **** Applicable and capable Older siblings that are given permission from the child’s parents MAY at the parents & handlers discretion take a ride with their brother/sister.***
- Children are not allowed to follow in front of, beside or behind the pony while it is moving and/or pulling the cart.
- No handling or leading the pony without the handlers permission! Must ask the handler(s) nicely and then the dress-up pony can go for a walk with the pony handler walking on the other side of “Toast.” 25 inch mini horse (Our minis are Therapy trained and very docile) This is a Perfect introduction to handling horses and ponies.)
- No jumping up and down on the cart.
- No food or drinks allowed while riding on the cart. No gum/candy/or anything edible while riding in the cart.

- *Eating candy, chewing gum, or having a popsicle while riding on our cart poses a choking hazard for children*
** Safety first! **
- No feeding the pony (without permission from the pony handler(s). *Baby Carrots may be given to the handler to give to the pony after your event is finished. Thanks for your cooperation on this matter. :)
- Please be kind and respectful to the pony handlers, We love to provide our miniature horses to your special event and would love to provide our minis to your event again!
- Your **TIPS** are, as always, greatly appreciated. Your guests and/or the primary event host are always welcome to deposit your generous contribution to our pony funds in the **Pony Party Bus** tip box! *Tips primarily go to the care of our minis, and also our dedicated & friendly employees*
- *Check with the primary mini pony handler at your event to see what organization a significant portion of the event tips are being donated to at your event.” (ie. Gentle Carousel Miniature Therapy Horses - 501c3 that provides teams of tiny mini therapy horses to work with adults and children each year inside hospitals, hospice programs, and with families who have experienced traumatic events.)
- Be good listeners and remind your children of this rule for the child’s overall safety during the party. Thanks!
- **No loud noises, yelling, running or pushing around the pony!**
- Pony Party Bus reserves the right to kindly decline participants a cart ride due to behavioral and/ overall safety reasons. *Hayley is an accomplished equestrian, has always owned/ridden and had horses, and hires ONLY well-trained horse-knowledgeable & kid friendly production assistants!*
